# Singing and Speech Darien De Lu Presents W.I.L.F. By Dave Flanders

Darien De Lu of the Woman's International League for Peace and Freedom (WILPF) was AOF's April speaker. Darien said WILPF has been around for 90 years and has endeavored to spread peace around the world. The organization got started mostly by woman in an effort to prevent World War One. During the Viet Nam War, membership increased dramatically. It has proved endurance over time.

Darien began her presentation singing a peace activist song to set the mood and to illustrate what it is like to be a peace advocate. Dance and art are also important to WILPF.

The Women's International League," as she phrased it many times, has creative ways of focusing people on the reality of war and militarism. For example, April 15, WILPF is having a bake sale. "Each muffin will cost one half of a million dollars to help subsidize George Dubyas' war effort."

WILPF is against money thrown down the toilet on star wars--a missile defense system that top scientists say can't work and never will work. Billions of dollars could be spent more wisely. WILPF is committed to dismantling the current "war economy," which is based on the national and international manufacture and sale of nuclear weapons and conventional arms.

Through education and public awareness, WILPF works to expose the domination of weapons manufacturers over Washington legislators, the misuse of the federal budget, and the vested interests of US foreign policy. Rapidly growing corporations, whose primary goal is the increase shareholder wealth, are undermining democracy.

WILPF's campaign has two equally important goals to combat this usurpation of power: (1) to return economic institutions to their proper role working for the good of society and (2) to reclaim democracy by exploring its meaning, examining our interactions, and practicing truly democratic behavior in our communities.

about where the money (all above the day's room rent) will be going.

Sacramento's receiving home is run by a nonprofit organization and provides "a safety net for the area's abused and neglected children between the ages of 2 and 17." The website of the organization (http://crhkids.org) is well worth a visit. There, among the varied information offered, you will be able to read the following about the services:

We are the shelter for abused and neglected children in Sacramento County . We are the *only* facility of our kind in the County.

We are a short-term emergency shelter that provides a proven early intervention strategy that stabilizes, normalizes, and produces improved long term outcomes for children.

Our kids are between the ages of 2 and 17 and all come to us having suffered some form of abuse or neglect, often severe. Neglect involves lack of care, no food in the home, absent parents, filthy conditions. Abuse involves hitting, beating, burning, or sexual trauma.

75% of our children arrive here via law enforcement; city police or sheriffs department. The average length of stay is

25-30 days.

Kids come from all parts of Sacramento County. They tend to come from communities characterized as pockets of poverty but they come from all zip codes. We track this data.

O E-mail newsletter O Postal mail

For many traumatized and brutalized children taken from abusive parents, the Children's Receiving Home is their first stop and best hope for a brighter future. In this friendly haven, staffed with counselors, teachers, social workers, and nurses, children experience basic screenings that include medical, dental, and educational assessments before the children are placed in a foster care home.

Licensed annually by the State Depart-

ment of Social Services, the Children's Receiving Home is available twenty-four hours each day, seven days per week, for the admission of children. It provides comprehensive services to children while they are staying at the facility including medical and dental care, mental health assessments, on-site teachers provided
