In addition to AOF's annual elections (full details begin on page four), AOF is pleased to welcome the holiday season by hosting Matt McCormick, associate professor of philosophy at CSUS, as our December speaker. Dr. McCormick is working on a new book about "The Case Against Christ," and will be discussing various examples of how Jesus belief is out of whack with people's good sense and reasonableness.

The following is an abstract of Dr. McCormick's book:

The book makes the case that the average, educated 21st century American should not believe that Jesus was a divine being who was resurrected from the dead 2,000 years ago. Believing that Jesus was resurrected from the dead on the basis of the evidence available to us—primarily a small group of testimonial stories recorded in the Gospels—is inconsistent with our other conventions concerning belief and evidence.

El Porvenir Founder Carole Helper

November Meeting RecapBy Jillian Stanley

At the October general meeting, Carole Harper, co-founder of the organization El Porvenir ("the future") talked about the revolution and political situation in Nicaragua, where she lived from 1986 to 1989, working with Habitat for Human-

ity. She described the revolution by using the stages of a revolution as described in Crane Brinton's book, The Art of Revolution, published years before the events in Nicaragua. In Brinton's analysis of several revolutions around the world, one step is when intellectuals take on a new belief; later comes the "Reign of Ter-

ror and Virtue" which is a type of religious fervor; this is succeeded by "thermidor," a time of calm and moderation. (Note: Wikipedia says that this term, from the French Revolution, "has come to mean the phase in some revolutions when power slips from the hands of the original revolutionary leadership

and a radical regime is replaced by a more conservative regime.")

In Nicaragua, by the time the people revolted against long-time dictator Somoza in 1979, he had only his personal guard for support. After

the overthrow of Somoza, the country was governed by the Sandinistas (FSLN), and in 1984 Nicaragua held its first free elections in seventy years. There was a 90% turnout, and Daniel Ortega was elected president. In spite of the opposition of the Contras, which were backed by the CIA, the new gov-

ernment was able to implement many of its election promises,

including land reform and clean energy. The government, however, did not emphasize freedom of speech. Carole recounted her own experience of being arrested for taking a photo of a government building. (She was released, but without the photo.)

There are numerous other ordinary cases where we have a body of comparable evidence, yet we would reject the analogous conclusion for a supernatural claim like the resurrection. In fact, there are numerous cases where we have better evidence—both in terms of quantity and quality—and we reject the conclusion, so accepting the Jesus story is grossly out of synch with our other beliefs. The Salem Witch trials and a hypothetical alien abduction cases illustrate the point. I give several other considerations that fortify the doubts: problems with the transmission and reliability of the Jesus story made clear by probability theory, modern developments in epistemology and recent empirical research psychology all undermine our accepting the Jesus story as communicated to us by the early Christians through the Bible. I then turn to several additional discussions that complete the case against Christ: the existence of so many other religions and "dead" gods presents a problem for Christianity, performing miracles cannot be reconciled with the characterization of God as the all powerful, all knowing creator of the universe, several problems arise from the faith response and from a non-literal approach to Christian doctrines.

Dr. McCormick is a contributing author to "The Impossibility of God," edited by Michael Martin and Ricki Monnier. At CSUS, Dr. McCormick teaches a philosophy seminar on atheism, the only one of its kind in the nation.

A Personal Success Story

The Pros and Cons of Proselytizing

I parted with the Catholic Church in sophomore year of high school and started to pronounce myself as being an atheist early in college. From that time onward, a huge battle of words and ideas ensued between the rest of my family and myself. We freely engaged in debate over the outstanding unresolved contradictions inherent in god and evil, a loving god punishing his creations in hell for eternity, especially since He knew before He made them what they would choose to do in life. Freewill versus omniscience, progression of mythologies to one invisible all powerful god, the vague forever undefined nature of heaven, science versus simplistic theological reasoning, the woefully inadequate explanation offered by religion as to the nature of our world, changing morality and ethics over time versus a divinely inspired word of god written in stone in a Bible locked in antiquated ideas - these questions haunted my mind and my family bore the brunt of my criticism and intellectual challenge for years.

My dad and I were best friends throughout his whole life, we were as tight as any father and son I ever met, but he was a die-hard Catholic and I continually ridiculed the Church's teachings, relevance to society, and importance to an individual's happiness. I guess we reached an equilibrium where we knew where each of us stood, and his beliefs became less important than other aspects of our relationship. I will never forget a time I was dissecting a rat and dad asked me how something that complex could have evolved. I countered how could something this complex have been invented by a god? My dad died in 1992 and I went to his service in the church where I as an alter boy had assisted the priest in serving mass for 40 consecutive days in lent for 5

years. During my Dad's funeral service, I hated every minute of being in that church. My dad deserved better than the ritual which was performed, so meaningless to what he meant to the world. My emotional laden speech I gave at the burial site was completely devoid of any spirituality, and his friends said that was the highlight of the ceremony. So my dad was faithful to his Catholic beliefs till the end. My Mom was less stringent in her thinking and listened to me ridicule the ideas of heaven and that my dad was looking down on us. My mom is now 87, and is nearing the end of her life. I just had a conversation with her at her bedside in the nursing home after a heart attack and she admitted she really didn't take the church seriously. Did she want to attend mass? No. Did she want to see a priest before she died? No. Wow, that was something! I even took a video of our conversation, which I may put on the web in a few years.

My ex-girlfriend always told me I was wasting my time arguing with believers. As a psychologist, she felt the more you challenged the believers, the harder they dug in their heels fighting against you, and the

more convinced they became that they were right. She finalized her argument with the question of how many people have I converted out

of being religious. I had to honestly answer I didn't know if there was even one.

Well, now I have a different answer to that question. I was able to help one person see the follies of religion, and to see through its false hopes to a place of questioning more than believing. So I can honestly say that my efforts did succeed with someone, someone very special to me, who I will remember for the rest of my life, my mom.

The election of Violeta Barrios de Chamorro (widow of the assassinated newspaper editor) as president in 1990 represents "thermidor," in Carole's interpretation. The Sandinistas still were represented in the legislature, but the tone of the government was more moderate, and many exiles returned, bringing a business class back to Nicaragua. The 2007 elections seem to be contrary to Brinton's theory of revolution, as the FSLN returned to power. But even Ortega seemed less radical: he married his girlfriend in the Catholic church. The speaker was honest about both the failings and accomplishments of the Nicaraguan government. Abortion is illegal, a victory for the conservative side. But the agrarian land reforms stand, and there is universal education and free health care. The Popular Army, led by Sandinistas, is trusted and respected by the people.

In response to an audience question about attitudes towards homosexuality, the speaker acknowledged that homophobia is the norm in Latin America. However, there is a gay-rights march every year in Nicaragua, which, she observed, takes "real guts." About unions, she stated that the Sandinistas have given people the right to unionize, but there are sweatshops owned by companies from Taiwan and Korea that have been accused of killing union organizers. Answering questions about U.S. policy towards Nicaragua, the speaker stated that in spite of Obama's election, some people in the State Department have been there since the Reagan era, and she characterized Secretary of State Hilary Clinton as a hawk. Questions were also asked about Honduras and Cuba. Honduran president Zelaya had been turning more to the side of the poor and was thus seen as a threat by the right-wing business class—hence the military "coup" last summer. The Cuban revolution did not follow Crane Brinton's outline, as after the victors took power, no moderates remained—they were all in exile.

The following change regarding term limits for AOF Board of Directors, having been approved by the Board, was presented to the members by Mynga Futrell and was approved by vote: "Directors having served three consecutive years shall then be ineligible to serve for a period of one year. No more than two directors may be deemed ineligible in a given year. If more than two members have served three or more consecutive years, the member(s) remaining eligible to hold office will be subject to approval by the board of directors."

The new wording will allow for a transition to the term limit requirement without undue disruption of the board's function.

Bev Church announced that AOF is now a member of the **Sacramento Area Coalition for Reason**. ACOR will fund a bus ad, which will feature our name and website link; this is targeted to occur in January.
